

INSTRUCTIONS FOR "NOT IN ENGLISH ALPHABET RULES"

For ordering individuals cards that are not in the English alphabet (such as Chinese) follow ABI Banks rules listed below. This is the "final" say from ABI's RISK group on what is acceptable and what they require from individuals whose Passports are in partial English (acceptable) but whose address verification documents are in another alphabet (such as Hebrew etc.)

If you comply with the following rules listed below they will approve the documents:

- **Attorney or notarized letter, stamped, stating they have certified / notarized the ID's and address verification documents. If there is a group being certified all at once, the letter must contain the complete list of names that correspond with the list.**
- **A Translated list that contains Name in English, Name in current language, Passport number, Country of passport, Original address, English address, Company Type and number of document and Date of address verification document.**
- **Address verification Document (as per normal procedure)**
- **Passport (as per normal procedure)**

You can have multiple people on one list to save time and money (see attached). The documents cannot be expired and must be clear.

The four items listed about must be attached as a .jpg for each card if the address verification is in another alphabet other than English.

* If the address verification is written in the English alphabet we only need the Passport (which is usually in English or Partial English) and Address verification docs - like normal.

- Attorney or notarized letter, stamped, stating they have certified / notarized the ID's and address verification documents that corresponds with the translated list.
